ORDINANCE NO. 968, S. 1997

ORDINANCE MANDATING THE CITY TREASURER TO  
DEPUTIZE BARANGAY TREASURERS TO COLLECT  
COMMUNITY TAX PAYABLE BY INDIVIDUAL TAX PAYERS

WHEREAS, it is the policy of the State to provide Local Government Unit for a genuine and meaningful local autonomy to enable them to attain their fullest development as a self reliant community;

WHEREAS, towards this end, the State shall provide a more responsive and accountable local government structure instituted through a system of decentralization;

WHEREAS, the barangays as a Local Government Unit and as partners for progress of Pasay City need be given more powers, authority, responsibilities and resources for them to attain their fullest development;

WHEREAS, the Local Government Code of 1991 authorized the City Treasurer to deputize Barangay Treasurers who are properly bonded, to collect community tax payable by individual tax payers if the former is authorized by the ordinance levying said tax;

NOW THEREFORE, be it ORDAINED, as it is hereby ORDAINED, in session duly assembled, that:

**SECTION 1. DEPUTIZATION AND SCOPE OF AUTHORITY.** - The City Treasurer is mandated to deputize Barangay Treasurers to collect community tax, payable by individual tax payers only;

**SECTION 2. QUALIFICATION.** - The deputized Barangay Treasurer must post cash bond not less than FIVE THOUSAND (P5,000.00) PESOS and must attend orientation to be conducted by the Office of the City Treasurer on the issuance of Community Tax Certificate;

**SECTION 3. REQUISITION OF COMMUNITY TAX FORMS.** - The deputized Barangay Treasurer shall secure or requisition on consignment, from the City Treasurer the blank forms of Community Tax Certificates and shall pay the cost of printing and distribution thereof pursuant to Section 6 hereof;

SECTION 4. JURISDICTION. - The deputized Barangay Treasurer shall only collect Community Tax within the territorial jurisdiction of the barangay;

SECTION 5. REMITTANCE OF PROCEEDS. - The deputized Barangay Treasurer shall turn over the proceeds of community tax collection every end of the month, rendering a monthly accounting of the collection, together with the duplicates of the Community Tax Certificate issued. The City Treasurer shall prepare the necessary forms for purposes of accounting;

SECTION 6. ALLOCATION OF PROCEEDS OF COMMUNITY TAX. - The proceeds of community tax collected through the Barangay Treasurer shall be apportioned each quarter, as follows:

- a) Fifty percent (50%) shall accrue to the general fund of the City of Pasay;
- b) Fifty percent (50%) shall accrue to the general fund of the barangay where the tax was collected, less the cost of printing and distribution of the requisitioned blank form of the Community Tax Certificates;


SECTION 7. RESCISSION OF AUTHORITY AND CONFISCATION OF CASH BOND. - Mere delay in the remittance of the proceeds of collection pursuant to Section 5 hereof is sufficient ground for the City Treasurer to rescind the authority to collect community tax and confiscate the cash bond posted by the Barangay Treasurer;

SECTION 9. EFFECTIVITY. - This ordinance shall take effect immediately upon its approval and publication in a news paper of general circulation in the City of Pasay;


