ORDINANCE

AN ORDINANCE PROVIDING FOR ONE SIDE PARKING AT
COLAYCO STREET, PASAY CITY.

WHEREAS, Barangay Ordinance No.01-96 is an ordinance officially adopted by the Sangguniang Panlungsod of Barangay 159-Zone 7, Pasay City, which declares the left portion of Colayco Street corner Villareal Street as well as Colayco Street corner Libertad Street as a "FREE PARKING SPACE" and a ONE WAY VEHICULAR TRAFFIC to serve and facilitate the movements of commuters to and from different areas of Pasay City;


WHEREAS, the CODA vehicles are the one availing the use of the east side of Colayco Street as parking area through the effectivity of the above-cited barangay ordinance;

WHEREAS, these vehicles are public utility vehicles plying within the city for the benefit and convenience of the commuters.

NOW, THEREFORE, BE IT ORDAINED AS IT IS HEREBY ORDAINED, by the Sangguniang Panlungsod of Pasay in session duly assembled to provide as it hereby provides for the east side parking at Colayco Street towards Libertad Street (left side of Colayco), Pasay City.

ENACTED this 8th day of October in the Year of Our Lord Nineteen Hundred and Ninety-Six.



An ordinance approved by the Barangay Council authored by Barangay Chairman EDGARDO F. CUNETA, for free parking space on its regular session last May 17 1996, held at the Barangay Hall declaring the left portion of COLAYCO STREET corner **VILLAREAL** STREET as well as COLAYCO ST. corner LIBERTAD ST., as a "FREE PARKING SPACE" and a one-way vehicular traffic flow coming from P. BURGOS ST. to either F. ROSARIO ST. or VILLAREAL ST. towards LIBERTAD ST. to serve and facilitate the movement of commuters to and from different areas of Pasay City.

PROVIDED, however that the attached excerpts of CODA by-laws as forwarded and studied by the Barangay Council be strictly adhered to including Barangay Rules and Regulations set by the Barangay Council in connection with this ordinance.

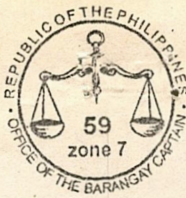


In reference to your letter dated May 15, 1996 asking this Barangay Council to grant you permission to a free parking space, I am glad to inform you that upon careful deliberation by the Barangay Council, your request has been granted.

Provided, however, that you will conform to Barangay Rules and Regulations stated as follows:


1. Any CODA vehicle should always give way to a Barangay 59 resident when parking space is needed.
2. No parking on the right side of COLAYCO ST.
3. No unnecessary blowing of horns.
4. No CODA driver is allowed to urinate on the perimeter of the parking space.
5. Always maintain cleanliness in the area.
6. No CODA driver or member is allowed to gamble or drink liquors in the process of waiting for their turns.
7. Any errant driver should be dealt with and punished for violations.

Serious violations, upon deliberation by the BARANGAY COUNCIL can cause termination or cancellation of your permit.


