A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR IMELDA CALIXTO-RUBIANO TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT IN BEHALF OF THE CITY GOVERNMENT OF PASAY WITH THE MUNICIPALITY OF TANAY, RIZAL REPRESENTED BY HONORABLE MAYOR REX MANUEL C. TANJUATCO AS TO THE TWELVE (12) HECTARES PASAY CITY HOUSING SITE LOCATED AT SITIO SAMPIRO, BARANGAY PLAZA ALDEA, TANAY, RIZAL, SUBJECT TO COMPLIANCE WITH ALL APPLICABLE LAWS, RULES, AND REGULATIONS

WHEREAS, the draft of the Memorandum of Agreement between the City of Pasay and the Municipality of Tanay headed by Honorable Mayor Rex Manuel C. Tanjuatco as to the Twelve (12) Hectares Pasay City Housing Site located at Sitio Sampiro, Barangay Plaza Aldea, Tanay, Rizal was forwarded by the Office of the Honorable City Mayor Imelda Calixto-Rubiano to the Sangguniang Panlungsod in an endorsement dated November 16, 2021 with a corresponding request for the adoption of a Sanggunian Resolution authorizing her to sign the same subject to existing laws, rules and regulations;

WHEREAS, under the said agreement, the City of Pasay is recognized as the registered owner of a parcel of lot located in Sitio Sampiro, Brgy. Plaza Aldea, Tanay, Rizal. It will develop the said property, with an area of TWELVE (12) HECTARES known as the "PASAY CITY HOUSING SITE". The purpose of the partnership between the two local governments is to provide for a relocation site and/or resettlement area for the informal settlers of the City of Pasay comprising of not more than four hundred (400) informal settler families;

WHEREAS, the subject matter was scheduled for hearing on February 2, 2022 before the Committee of the Whole of the Sangguniang Panlungsod wherein Mr. Ian Vendivel, Housing and Homesite Regulation Officer IV of the Urban Development & Housing Office of the City of Pasay and Honorable Mayor Rex Manuel C. Tanjuatco of Tanay, Rizal, among others, were given opportunity to discuss the contents of the Memorandum of Agreement and its benefits to the informal settler families of the two local governments in providing them with housing relocation sites;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod, in a session duly assembled, AUTHORIZING THE HONORABLE CITY MAYOR IMELDA CALIXTO-RUBIANO TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT IN BEHALF OF THE CITY GOVERNMENT OF PASAY WITH THE MUNICIPALITY OF TANAY, RIZAL REPRESENTED BY HONORABLE MAYOR REX MANUEL C.
