A RESOLUTION APPROVING AND ADOPTING THE PASAY CITY HEALTH BOARD RESOLUTION NO. 04-E, SERIES OF 2024 ADOPTING LOCAL INVESTMENT PLAN FOR HEALTH/ANNUAL OPERATION PLAN AS THE STRATEGIC AND INVESTMENT PLAN OF THE CITY-WIDE HEALTH SYSTEM APPROVED ON APRIL 26, 2024, SUBJECT TO ALL APPLICABLE LAWS, RULES AND REGULATIONS ON THE MATTER

WHEREAS, the Department of Health Formulated the FOURmula One (F1) for Health as the implementing framework for health sector reform in 2005. The Province-wide Investment Plans for Health (PIPH) was introduced in 2006 to strengthen local health planning and was implemented in 16 pilot convergence provinces. The strategy of investment planning was later expanded to all other Provinces, Highly Urbanized Cities (HUCs), Independent Component Cities (ICCs) which likewise developed their City-wide Investment Plans for Health (CIPH);

WHEREAS, the PIPH/CIPH was the key instrument in forging DOH-LGU partnership to achieve health sector goals. In order to formalize the partnership, a five-year Memorandum Of Agreement (MOA) and annual Service Level Agreement (SLA) were signed between the DOH and the Province/HUCC/ICC. The MOA and SLA were later merged and renamed as Terms of Partnership (TOP);

WHEREAS, the PIPH/CIPH has since been institutionalized and renamed as Local Investment Plan for Health (LIPH) and utilized as 1) Localization tool of national health programs; 2) Basis for resource mobilization and investment planning towards attaining local and national health goals and 3) official means for the DOH and development partners LGUs;

WHEREAS, the LIPH is the three-year planning cycle that is applied at all levels in the locality – barangay, municipality/city, district and province. Annual Operational Plans (AOPs) are prepared for every year of the planning cycle;

WHEREAS, in 2018, Administrative Order 2018-0014 or the “Strategic Framework and Implementing Guidelines for FOURmula One Plus for Health” was issued. It mandates that technical assistance from the DOH be consolidated and matched with the needs outlined on the LIPH;

WHEREAS, the planning exercise aspires to attain the goals set in each of the elements that make up a responsive health system as indicated in the planning framework – service delivery, regulation, health financing, health information system, and human resource for health. An exemplary leadership and governance steers the health system that shall result to desired health outcomes;

WHEREAS, the Department of Health’s LIPH aims to guide and direct health Program Managers to develop health system to attain Philippine Health Agenda goals such as better health outcomes, more responsive health system and financial protection. Related to this, Pasay City Health Office thru the Local Health Board, created the LIPH technical working group;

WHEREAS, LIPH Technical Working Group (TWG) is chaired by City Health Officer and co-chaired by City Health Office Planning Unit Head. The members are the following: City Budget Officer, City Planning Officer, PCGH Medical Director, Sanitation Division Head, DMO IV DOH-MMCHD, PSWDD Head, Nurse Supervisor, Midwife Supervisor, Secretariat, IT Specialist/Documentor, HEPU, CESU, DRRMHU;

WHEREAS, the members of the expanded TWG are ABC President, Chairman, Committee on Health, Representatives of Pasay City Medical Society, Pasay Nurses Association, Pasay Midwives Association, Pasay Dental Association, Barangay Health Worker, Sangguniang Kabataan President, Senior Citizen President, Homeowners Association President and representatives of other health – related organization;

WHEREAS, the passage of RA 11223 or the Universal Health Care (UHC) Act an its implementing Rules and Regulations (IRR) in 2019, the significance of LIPH is highlighted. Section 22 of the UHC Act states that “the national government, through the DOH shall provide financial and non-financial matching grants. In accordance with the approved province-wide and city-wide health investment plans;

WHEREAS, the City Health Office of Pasay annually makes a LOCAL INVESTMENT PLAN FOR HEALTH/ANNUAL OPERATIONAL PLAN for activities and programs in accordance with DOH rules and regulations; and

WHEREAS, there is a need for the Pasay Local Health Board to pass a board resolution adopting the LOCAL INVESTMENT PLAN FOR HEALTH/ANNUAL OPERATIONAL PLAN of the Pasay City Health Office to ensure shared responsibilities and accountabilities among members of the health, for the delivery of population based services including those that impact on the social determinants of health.

WHEREAS, pursuant thereto, the Pasay City Local Health Board adopted Resolution No. 04-E, Series of 2024 approved on April 26, 2024 “*Adopting Local Investment Plan for Health/Annual Operational Plan as the Strategic and Investment Plan for the City-Wide Health System*”;

WHEREAS, on December 05, 2024, the Honorable City Mayor Imelda Calixto-Rubiano endorsed to the Sangguniang Panlungsod a copy of the above mentioned resolution for approval and adoption of the Sangguniang Panlungsod;

NOW THEREFORE BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod, in session duly assembled, **APPROVING AND ADOPTING THE PASAY CITY HEALTH BOARD RESOLUTION NO. 04-E, SERIES OF 2024 ADOPTING LOCAL INVESTMENT PLAN FOR HEALTH/ANNUAL OPERATION PLAN AS THE STRATEGIC AND INVESTMENT PLAN OF THE CITY-WIDE HEALTH SYSTEM APPROVED ON APRIL 26, 2024, SUBJECT TO ALL APPLICABLE LAWS, RULES AND REGULATIONS ON THE MATTER.**




