WHEREAS, the Comprehensive Land, Water, and Air Use Plan (CLWAUP) for the period 2023–2034 has been formulated through an inclusive, participatory, and evidence-based planning process, ensuring alignment with national and regional policies, guidelines, and frameworks, including the Philippine Development Plan (PDP);

WHEREAS, the proposed CLWAUP has undergone a series of consultations, technical reviews, and public hearings involving key stakeholders, including local government officials, non-governmental organizations (NGOs), civil society organizations (CSOs), private sector representatives, and the general public;

WHEREAS, the proposed CLWAUP outlines the long-term vision, development goals, and spatial strategies of Pasay City as a Sustainable Eco-City, serving as a comprehensive guide for land, water, and air use, urban development, environmental management, disaster risk reduction, and climate change adaptation;

WHEREAS, on January 28, 2025, the Local Development Council approved the Comprehensive Land, Water, and Air Use Plan (CLWAUP) of Pasay City for the period 2023–2034;

WHEREAS, on the same day, the Honorable City Mayor Imelda Calixto-Rubiano endorsed to the Sangguniang Panlungsod the mentioned CLWAUP and CDC Resolution requesting for the issuance of a resolution approving the same;
