WHEREAS, the University of the Philippines Manila issued Memorandum No. UPMLO-2025-559 with the subject “Memorandum of Agreement (MOA) between the University of the Philippines (UP) and the City of Pasay for the Project Entitled “Phase 2 Randomized, Double-Blind, Active-Controlled Study Evaluating the Safety and Immuno-Genecity of IVT PCV-25 in Healthy Infants Administered with the WHO Expanded Programmed on Immunization 3+0 vaccine Schedule”;

WHEREAS, the abovementioned study aims to conduct clinical vaccine trial with the health centers enumerated below and such other possible health centers that will join the clinical studies:

1. Doña Nena Health Center;
2. Doña Martha Lying-In Center;
3. Pasay General Hospital; and
4. MIA Health Center

WHEREAS, pursuant thereto, UP Manila shall give institutional support by providing free vaccines whenever available with requests coming from the communities of Pasay City as part of its vaccine missions and advocacy programs as well as educate community in raising awareness of the value of vaccine preventable diseases, among others;

WHEREAS, moreover, the agreement becomes effective upon its execution by both parties and shall remain in effect for five (5) years from said date of execution, at which time the parties may negotiate to extend the agreement a further term. However, the agreement may be terminated by either party upon sixty (60) days written notice;

WHEREAS, on May 8, 2025, the Honorable City Mayor Imelda Calixto-Rubiano endorsed to the Sangguniang Panlungsod a copy of the said Memorandum of Agreement and requested for the adoption of a Resolution granting her authorization to sign the same.
