ORDINANCE NO. 192, S-1993

ORDINANCE

AN ORDINANCE PROHIBITING SCALPING WITHIN THE JURISDICTION OF
THE CITY OF PASAY.

Sponsored by Councilor Greg F. Alcera

SECTION 1. Title - This law shall be known as the Anti-
Scalping Ordinance of Pasay City.

SECTION II. Definition,

- a. scalping - is the practice of selling or re-selling of any admission, privilege, or gratuity tickets by any unauthorized dealer or agent for the purpose or price other than those explicitly stated or printed on the tickets, either at a discount or premium.
- b. unauthorized dealer or agent - any person other than those certified dealers or agents thereof who could not provide or present any certification which is verifiable as to the nature of their operations.

THEREFORE, BE IT ORDAINED, by the Pasay City Council in a session duly assembled that:

SECTION III. It shall be prohibited for any person or entity to engage in scalping activities within the jurisdiction of Pasay City.

SECTION IV. Any person who violates or causes to violate any provision of this ordinance shall be subject to the following penalties;

- First Offense : P5,000.00 fine
Second Offense: P5,000.00 fine and imprisonment of not less than 30 days
Third Offense : P5,000.00 fine and imprisonment of not less than six months

SECTION V. Repeal - Any existing law, ordinance or resolution whose provisions are contrary to this ordinance are hereby repealed.

SECTION VI. Effectivity. - This ordinance shall take effect after its passage and approval, compliance with the requirement of posting in three (3) conspicuous places in the city and its final publication, once in a newspaper of general circulation in the city.

ENACTED in the City of Pasay, Philippines, this 23rd day of February, in the Year of Our Lord, nineteen hundred and ninety three.


