ORDINANCE NO. 736 S-1997

**AN ORDINANCE PROVIDING FOR THE ADMINISTRATIVE SUPPORT SERVICES TO THE OFFICE OF SENIOR CITIZENS (OSCA) AND PROVIDING FUNDS THEREFORE.**

WHEREAS, Republic Act 7432 mandates the maximization of the contribution of Senior Citizens to society, and grants them special privileges and benefits, and the DILG Memo Circular No. 93-177 addressed to all local government units providing policy directions for the effective implementation of RA7432 has already been effected;


WHEREAS, Pasay City Ordinance No. 191 S-1993 has effected special privileges and the necessary framework to implement and effect RA 7432;


WHEREAS, there is a need to preserve whatever gains was had in the organization of various Senior Citizen's groups in Pasay City, and ensure the delivery of basic services and privileges as mandated by law;

**NOW THEREFORE BE IT ORDAINED BY THE PASAY CITY COUNCIL IN A SESSION DULY ASSEMBLED THAT;**

1. The Administrative Secretariat under the Office of Councilor Greg F. Alcera be maintained and a majority of its personnel be manned by registered Pasay OSCA members;
2. The amount of P156,000.00 be appropriated for the salaries and allowances of personnel to be designated to man the OSCA Office effective January - December, 1997.
3. The amount of P50,000.00 be appropriated for the purchase and/or printing of necessary documents and office supplies;
4. That the above-mentioned amounts be taken from the unused portion of the Special Events Fund or the Special Projects Fund of the Office of Councilor Greg F. Alcera chargeable to 1997 Budget.
