ORDINANCE NO. 690 S. 1996

AN ORDINANCE PROHIBITING VENDORS, PEDDLERS AND AMBULANT PEDDLERS INSIDE THE CITY PUBLIC CEMETERY AT DON CARLOS REVILLA (FORMERLY SGTO. MARIANO) STREET , PASAY CITY DURING ALL SAINT'S DAY (TODOS LOS SANTOS) CELEBRATION EVERY NOVEMBER 1ST .

WHEREAS , every November 1 st, the whole nation celebrates All Saint's Day , and people from all walks of life converge at cemeteries to visit their beloved dead ;

WHEREAS , vendors , peddlers and ambulant peddlers are just nuisance and an added factor in the congestion , commotion and confusion inside the City Public Cemetery ;

WHEREAS , such congestion , commotion and confusion have its bad effects on the sanitary condition and , most often , present an opportunity for illegal activities such as picpocketing , snatching and mashing of chests and other private parts of female visitors by bad elements due to the presence of vendors , peddlers and ambulant peddlers ;

WHEREAS , cemetery visitors will have difficulties locating their beloved dead due to the congestion , commotion and confusion , created by these vendors , peddlers and ambulant peddlers .

NOW, THEREFORE , BE IT ORDAINED , by the Sangguniang Panlungsod of Pasay in session duly assembled , that -

Section 1- All forms of vending inside the City Public Cemetery are hereby prohibited at Don Carlos Revilla (formerly Sgto. Mariano) Street, Pasay City .


Section 2 - To give a chance to vendors , peddlers and ambulant peddlers to earn on this special occasion , certain section outside of the city public cemetery will be designated as vending area which is about thirty (30) meters from the main gate facing Don Carlos Revilla (Formerly Sgto. Mariano) Street , and thirty meters (30) from the main gate going to Aurora Boulevard .


Section 3 - violation of this Ordinance , or any of its provision shall be fined Two Hundred (P200.00) Pesos , or an imprisonment of one (1) day , or both fine and imprisonment at the discretion of the Court .

Section 4 - EFFECTIVITY - This Ordinance shall take effect after its passage and approval , compliance with the requirement of posting in three (3) conspicuous places in the City or its final publication , once in a newspaper of general circulation in the City.

ENACTED this 29th day of October , 1996 at Pasay City , Metro Manila


