ORDINANCE NO. 831, S. 1997

AN ORDINANCE CREATING BARANGAY 201, ZONE 20, PASAY CITY

WHEREAS, the residents of the areas of Kalayaan Village, Teachers Bliss and Balagbag petitioned the Sangguniang Panlungsod to segregate the said areas from Barangay 183, Zone 20, Pasay City and create a new and distinct barangay out of said areas;

WHEREAS, Barangay 183, Zone 20 interposed "no objection" to the said petition for a distinct and separate barangay;

WHEREAS the barangay sought to be created satisfies the requirements on population and land area;

NOW THEREFORE, be it ORDAINED as it is hereby ORDAINED, in session duly assembled, that:

SECTION 1. CHARTER. - This Ordinance shall be known as the charter of Barangay 201, Zone 20, Pasay City;

SECTION 2. CREATION AND TERRITORY. - The Barangay 201, Zone 20, Pasay City is hereby created, shall comprise of the areas of Kalayaan Village, Teacher's Bliss and Balagbag, bounded on the East by South Super Hi-way, on the South by Creek (boundary of Pasay-Paranaque) and on the North by the Perimeter Fence of Manila International airport Authority (MIAA);

SECTION 3. CORPORATE CHARTER. - Barangay 201, Zone 20, Pasay City constitutes a political body corporate and is endowed with the attribute of perpetual succession and possess powers which pertain to a barangay unit;

SECTION 4 SEAL AND GENERAL POWERS. - The Barangay 201, Zone 20, Pasay City shall have a common seal, and may alter the same at pleasure. It may take, purchase, receive, hold, lease, convey and dispose of real and personal property for the general interest of the barangay, contract and be contracted with, sue and be sued, prosecute and defend to the final judgment and execution, and exercise all powers conferred by law;

SECTION 5. THE PUNONG BARANGAY. - The Punong Barangay shall be the Chief Executive of the barangay and shall hold office and receive compensation pursuant to law. He shall exercise such powers and perform such duties and functions as provided by the Local Government Code of 1991 and other laws;

**SECTION 6. SECRETARY.** - The Punong Barangay shall appoint a Barangay Secretary with the concurrence of the SANGGUNIANG BARANGAY. He shall exercise such duties and functions and shall receive compensation in accordance with law

**SECTION 7. SANGGUNIANG BARANGAY.** - The Sangguniang Barangay shall be the legislative body of the barangay and shall hold office, exercise such duties and functions and receive compensation as provided for by law;

**SECTION 8. BARANGAY TREASURER.** - The Punong Barangay shall appoint with the concurrence of the Sangguniang Barangay a Barangay Treasurer, who shall have charge of the finance of the Barangay and custodian of its funds. The Treasurer shall exercise such duties and functions and receive compensation in accordance with law;

**SECTION 9. PLEBISCITE.** - The COMMISSION ON ELECTION shall conduct a plebiscite on the fourth Sunday of April 1997 or on April 27, 1997 to ratify the creation of Barangay 201, Zone 20, Pasay City

**SECTION 10. BEGINNING OF CORPORATE EXISTENCE.** - The corporate existence of Barangay 201, Zone 20, Pasay City shall commence upon the ratification of its creation and upon interim appointment or election of its Punong Barangay and the Sangguniang Barangay.


**SECTION 11. EFFECTIVITY.** - This Ordinance shall take effect upon its approval and publication in a news paper of general circulation in Pasay City.
