ORDINANCE NO. 960, S - 1997

ORDINANCE

AN ORDINANCE MAKING IT UNLAWFUL FOR ANY UNAUTHORIZED PERSON TO CROSS THE POLICE LINE, FIRE DEPARTMENT LINE AND EMERGENCY LINE CORDONED OFF BY THE POLICE AND PROVIDING PENALTIES FOR VIOLATION THEREOF.

WHEREAS, one of the major concerns of the City Government of Pasay is to protect the welfare of its constituents;

WHEREAS, it is necessary that whenever major crimes against persons and/or property such as murder, homicide, arson, and the like wherein vital evidence that maybe found in the scene must be preserved, the police investigation agency should cordon off the said area;

WHEREAS, there is a need to make it unlawful for any unauthorized person to cross a Police line, Fire Dept. line and/or other emergency line cordoned off by the police should be discouraged by providing penalties for violation thereof.

NOW THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG PANLUNGSOD OF PASAY CITY, METRO MANILA, BY VIRTUE OF THE POWERS VESTED IN IT BY LAW, IN SESSION DULY ASSEMBLED, THAT:

Section 1. Crossing a Police line, Fire Dept. line and/or other emergency line by any unauthorized person which is cordoned off by the police investigation agency by reason of the commission of major crimes against persons or property is hereby unlawful.

Section 2. Any person violating this City Ordinance shall be penalized by paying a fine of P500.00 for every offense.

Section 3. This Ordinance shall take effect immediately upon approval.
