ORDINANCE NO. 981 - S 1997

AN ORDINANCE EXTENDING THE DEADLINE OF DECEMBER 31, 1997 FOR THE PAYMENT OF LAND TAX FOR THE YEAR 1997 AND THE DEADLINE OF JANUARY 20, 1998 FOR THE PAYMENT OF BUSINESS LICENSES, BOTH, TO JANUARY 31, 1998.

WHEREAS, Section 167 of the Local Government Code of 1991 provides that a local government unit is expressly authorized to either extend the deadline for the payment of local taxes or even waive the payment of interest, surcharges, or penalties on delinquent taxes;

WHEREAS, for the year 1997, considering that there is still a substantial number of taxpayers who has not yet paid their corresponding real property tax and who may opt to pay the same on the last day of the current year, but would unable to do so because of so many legal holidays during the month of December 1997, it would be for the benefits of the taxpayers if the deadline for the real property tax and business licenses be extended to January 31, 1998.

NOW, THEREFORE, BE IT ORDAINED BY THE PASAY CITY COUNCIL IN SESSION DULY ASSEMBLED THAT;

Section 1. Extension of Deadline for the Payment of Local Taxes and Licenses - The payment of land tax corresponding to the Year 1997 which will expire on December 31, 1997 is hereby extended up to January 31, 1998 and the payment of business licenses which will expire on January 20, 1998 is hereby extended up to January 31, 1998.

Effectivity - This ordinance shall take effect upon passage and approval of the Sangguniang Panlungsod, approval of the City Mayor and its publication in a newspaper of general circulation in the city.
