ORDINANCE MANDATING THE OFFICE OF THE CITY ACCOUNTANT AND CITY TREASURER TO DEVIDE THE INTERNAL REVENUE ALLOTMENT (IRA) OF BARANGAY 183, ZONE 20 AND ALLOCATE A PORTION THEREOF TO BARANGAY 201, ZONE 20, PASAY CITY IN ACCORDANCE WITH NUMBER OF POPULATION OF SAID BARANGAYS.

WHEREAS, pursuant to Ordinance No. 831, S. 1997, the areas of Teachers Bliss, Kalayaan Village and Balagbag was segregated from barangay 183 and Barangay 201 was created out of the said segregated areas;

WHEREAS, the Internal Revenue Allotment of Barangay 183 for the year 1998 is computed at FOUR MILLION EIGHT HUNDRED TWENTY THOUSAND SIX HUNDRED THIRTY EIGHT (P4,820,638.00) PESOS which allotment includes the share of Barangay 201;

WHEREAS, the number of population of Barangay 201 as per Census of September 1, 1995 is ELEVEN THOUSAND THREE HUNDRED EIGHTY FIVE (11,385) inhabitants while that of Barangay 183 is THIRTY FOUR THOUSAND THREE HUNDRED FORTY EIGHT (34,348) inhabitants;

WHEREAS, there is a need for the Office of the City Treasurer to devide the Internal Revenue Allotment of Barangay 183 and allot a portion thereof to Barangay 201 in accordance with their respective number of population.

NOW THEREFORE, be it ORDAINED, as it is hereby ORDAINED, in session duly assembled that:

SECTION 1- COMPUTATION OF INTERNAL REVENUE ALLOTMENT (IRA)- The Office of the City Accountant and City Treasurer are hereby mandated to devide the IRA of Barangay 183 and allot a portion thereof to Barangay 201 computed in accordance with their respective number of population to wit:

SECTION 2- EFFECTIVITY- This Ordinance shall take effect upon its approval and publication in a newspaper of general circulation in Pasay City;



DECLARING VERGEL STREET FROM TRAMO STREET TO TAFT AVENUE
FROM 6:00 A.M. TO 6:00 P.M. AS NO PARKING ON BOTH SIDES.

WHEREAS, Barangays 98 and 99, Zone 14, Pasay City passed resolution seeking to declare Vergel Street from Tramo Street to Taft Avenue as no parking on both sides from 6:00 A.M. to 8:00 P.M.;

WHEREAS, the COMMITTEE ON TRANSPORTATION recommended to the SANGGUNIANG PANLUNGSOD to amend Ordinance No. 267, S-1994 to declare the entire length of Vergel Street in the proviso of NO PARKING ON BOTH SIDES;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED in session duly assembled that:

SECTION 1 Section 6.25 of Ordinance No. 267, S-1994 is hereby amended to read as follows:

"SECTION 6.25 - Vergel Street from Cabrera Street to Taft Avenue from 6:00 A.M. to 8:00 P.M."

SECTION 2 EFFECTIVITY - This Ordinance shall take effect upon its approval and publication in a newspaper of general circulation in Pasay City.
