ORDINANCE NO. 989 1998

AN ORDINANCE PROVIDING FOR THE MODE AND AMOUNT OF PAYMENT FOR BUSINESS PLATE NUMBER REQUIREMENT OF ALL BUSINESS ESTABLISHMENTS IN PASAY CITY AS PER ORDINANCE NO. 977, SERIES OF 1997 WHICH REQUIRES ALL BUSINESS ESTABLISHMENTS AND OCCUPATIONAL UNDERTAKINGS TO REGISTER AND SECURE A BUSINESS PERMIT REGISTRATION PLATE BEFORE STARTING A BUSINESS IN THE CITY.

WHEREAS, there is a need to classify and stratify the amounts to be paid in securing business permit registration plate depending upon the nature of business activity conducted in the City of Pasay.

NOW THEREFORE, BE IT ORDAINED AS IT IS HEREBY ORDAINED, by the Sangguniang Panlungsod of Pasay in session duly assembled to provide as it hereby provides the following schedule of assessments of payments that is to be enforced as the mode and amount of payments for the business license plate over and above other assessments for annual municipal licenses, to wit:
