ORDINANCE NO. 978; S. 1997

ORDINANCE ENACTING RULES AND REGULATIONS IN THE PAYMENT OF ALLOWANCES TO POLICE OFFICERS AND PERSONNEL'S ASSIGNED IN PASAY CITY

WHEREAS, the City Mayor is vested with operational supervision and control over police units assigned in Pasay City;

WHEREAS, the SANGGUNIANG PANLUNGSOD has enacted Resolution No. 945, S-1997, strongly requesting the Philippine National Police (PNP) Regional Directorate to assign and deploy in Pasay City only police officers and personnel who are residents of Pasay City for at least ONE (1) year prior to deployment;

WHEREAS, Notwithstanding the aforesaid resolution the PNP Directorate continue to assign and deploy police officers and personnel in the City who lack ONE (1) year residency in Pasay City;

WHEREAS, the City Government has been paying allowances to all police officers and personnel performing duties in Pasay City;

WHEREAS, there is a need to enact rules and regulations in the payment of allowance to police officers and personnel to give teeth to Resolution No. 945; S-1997 so that its intention be satisfied and complied with;

NOW THEREFORE, be it ORDAINED as it is hereby ORDAINED, in session duly assembled that:

SECTION 1. ALLOWANCE - all police officers and personnel presently assigned and deployed in Pasay City shall be entitled to payment of existing allowance being provided by the City Government, except those assigned and deployed after the effectively of this Ordinance and has not acquired ONE (1) year residing prior to assignment and deployment;

SECTION 2.- PROOF OF RESIDENCY - All police officers and personnel who are assigned and deployed after the effectivity of this ordinance must show proof of residency consisting of Certification from the COMELEC of Pasay City and /or from the Barangay Chairman of the place where the assignee is residing to be submitted to the Office of the Mayor and Treasurer, respectively;

SECTION 3.-ACQUISITION OF ONE (1) YEAR RESIDENCY - All police officers and personnel assigned and deployed after the effetivity of this ordinance and who has not qualified for payment of the allowance, shall after ONE (1) year of continuos residency in Pasay City shall qualify for payment of existing allowances;

SECTION 4.- AMENDMENT/REPEAL - Any existing ordinance or provision thereof inconsistent with any provision of this ordinance are hereby deemed amended or repealed;

SECTION 5.- Any police officers and personnel assigned and deployed in Pasay City after the effectivity of this ordinance and who misrepresent himself to be a resident of Pasay City in order to qualify for payment of allowance being provided by the City and COMELEC personnel and Barangay Chairman who falsely certify to the required residency shall suffer the penalty of of ONE (1) year imprisonment;

SECTION 6.- EFFECTIVITY - This ordinance shall take effect immediately upon its approval ;
