## **ORDINANCE NO.** <u>969</u> S-1997

AN ORDINANCE CREATING THE PERSONNEL SELECTION AND PROMOTION BOARD TO ASSIST THE LOCAL CHIEF EXECUTIVE IN THE JUDICIOUS AND OBJECTIVE SELECTION OF PERSONNEL FOR EMPLOYMENT AS WELL AS FOR PROMOTION AND IN THE FORMULATION OF SUCH POLICIES AS WOULD CONTRIBUTE TO EMPLOYEE WELFARE.

WHEREAS, paragraph (a), Article 166 of the Rules and Regulations Implementing the Local Gov't. Code of 1991 states that "there shall be established in every province, city or municipality, a personnel selection board to assist the local chief executive or, where applicable, the presiding officer of the sanggunian in the judicious and objective selection of personnel for employment as well as for promotion;"

WHEREAS, paragraph (b) of the same article provided that "the personnel selection board shall be composed of the City Mayor, City Vice Mayor. Chairman, Committee on Civil Service, Chairman, Committee on Appropriation, City Personnel Officer and representative of Civil Service Commission as the *ex officio* member of the board;"

WHEREAS, par. ©, as the succeeding paragraph, also states that "personnel selection and Promotion Board shall formulate screening procedures and shall adopt criteria for evaluating candidates for employment or promotion in the first and second levels of the local government career service;"

WHEREAS, "par. (d), the last paragraph of Article 166, states that "the personnel selection board shall formulate policies on employee welfare in accordance with civil service law, rules and regulations;"

WHEREAS, the creation of the said office shall be the screening body in evaluating the personnel for employment.

**NOW THEREFORE, BE IT ORDAINED AS IT IS HEREBY ORDAINED,** by the Sangguniang Panlungsod of Pasay in session duly assembled to create as it hereby creates the Office of the Personnel Selection and Promotion Board to assist the local chief executive in the judicious and objective selection of personnel for employment as well as for promotion and in the formulation of such policies as would contribute to employee welfare.

**ENACTED** in Pasay City, this <u>4th</u> day of November in the Year of our Lord Nineteen Hundred and Ninety Seven.
