ORDINANCE NO. 958 S-1997

AN ORDINANCE PROVIDING FOR MEDICAL EXPENSE ASSISTANCE TO ALL DULY ELECTED AND INCUMBENT BARANGAY OFFICIALS AND THE BARANGAY TANOD AT THE PASAY GENERAL HOSPITAL AND PROVIDING FUNDS THEREFORE.

WHEREAS, the City recognizes the important role of the various barangay officials play in the daily performance of their duties;

WHEREAS, the salaries and allowances provided for these barangay officials are not commensurate to the hours and dedication they put in their avowed tasks, duties and obligation and at times not enough to sustain their own basic needs;

WHEREAS, the City Council recognizes the need to incentivize the compensation package being provided to these dedicated public servants.

NOW THEREFORE, BE IT ORDAINED AS IT IS HEREBY ORDAINED, by the Sangguniang Panlungsod of Pasay in session duly assembled that:

✓ **Section 1.0 - ACCOUNT** - A separate trust account be set p in the City's Chart of Accounts to specifically contain the amount to be appropriated and disbursed with respect to the provisions of this Ordinance.

✓ **Section 2.0 - FUND** - The amount of **TWO HUNDRED THOUSAND PESOS** (P200,000.00) be appropriated from funds not appropriated for any purpose in the 1997 budget, and likewise be subsequently appropriated annually for the purposes of the provisions of this Ordinance.

Section 3.0 - PROVISION - All duly elected Barangay officials shall be provided with a medical expense assistance amounting to **FIVE HUNDRED PESOS** to cover their initial cash outlay at the instance of their confinement or treatment at the Pasay general hospital during their incumbency:

Section 3.1 - COVERAGE

- a) All duly elected Barangay Officials and Barangay Tanods shall be entitled to the medical expense assistance upon confinement or treatment at the Pasay General Hospital.
- b) The maximum entitlement per elected Barangay Officials and Barangay Tanod shall be for a maximum of three (3) separate instances of treatment or confinement at the Pasay General Hospital per year.

Section 3.2 - PRESCRIPTION PERIOD - Entitlement to the medical expense shall be only during the incumbency of the elected Barangay Official.

✓ **Section 4.0 - ADMINISTRATION** - The Director of the Pasay General Hospital

shall submit to the City Treasurer at the start of each fiscal quarter a certified listing of barangay availing at the medical assistance as provided in this ordinance, validated by the Barangay Action Center, which shall be the basis for the City Treasury to transfer from the Special Trust Account as provided for in this ordinance to the account of the Pasay General Hospital the equivalent and corresponding amount of medical expenses credited to the said institution.













