AN ORDINANCE INCREASING THE PER DIEM/ALLOWANCE OF THE MEMBERS OF THE PEOPLE'S LAW ENFORCEMENT BOARD (PLEB) FROM FIVE HUNDRED (P500.00) PESOS TO ONE THOUSAND (P1,000.00) PESOS PER SESSION EFFECTIVE APRIL 1, 1997 AND APPROPRIATING THE NECESSARY FUNDS THEREFORE

WHEREAS the members of the PEOPLE'S LAW ENFORCEMENT BOARD (PLEB) is receiving a per diem/allowance of FIVE HUNDRED (P500.00) PESOS per session;

WHEREAS, the PLEB is holding sessions three (3) times a week, hearing two (2) to three (3) cases per session;

WHEREAS, the per diem being received by the members of the PLEB is not commensurate with their assigned tasks;

WHEREAS, the PLEB is among the lowest paid in Metro Manila, the highest among which are Quezon City, Makati and Muntinlupa;

NOW THEREFORE, be it ORDAINED as it is hereby ORDAINED, in session duly assembled, that:

SECTION 1. PER DIEM/ALLOWANCE. - The per diem/allowance of the members of the Pasay City PLEB is hereby increase from FIVE HUNDRED (P500.00) PESOS to ONE THOUSAND (P1,000.00) PESOS per session effective April 1, 1997;

SECTION 2. APPROPRIATION. - The sum of TWO HUNDRED SEVENTY THOUSAND (P270,000.00) PESOS is hereby appropriated from the available funds of the City Treasury to cover the increase from April 1, 1997 to December 31, 1997 and yearly thereafter, the fund to cover the said increase;

SECTION 3. EFFECTIVITY. - This Ordinance shall take effect upon its approval and publication in a news paper of general circulation in Pasay City.

ENACTED in the City of Pasay this <u>8th</u> day of April in the Year of Our Lord Nineteen Hundred and Ninety Seven.
