A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR IMELDA CALIXTO-RUBIANO TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT IN BEHALF OF THE CITY GOVERNMENT OF PASAY WITH THE DEPARTMENT OF SCIENCE AND TECHNOLOGY-NATIONAL CAPITAL REGION FOR THE IMPLEMENTATION OF THE PASAY CITY TRANSPORT GROUP OPERATIONS THROUGH INTEGRATION OF FAST CHARGING SYSTEM, SUBJECT TO COMPLIANCE WITH ALL APPLICABLE LAWS, RULES, AND REGULATIONS

WHEREAS, DOST-NCR's core functions are to plan and implement programs and projects on research and Development (R&D), technology transfer and the delivery of Science and Technology (S&T) services and develop institutional linkages with Regional Offices, other agencies, and local government and private organizations or entities for the effective planning and implementation of S&T programs in the region;

WHEREAS, the City Government of Pasay envisions to be sustainable eco city with an improved quality of life, empowered and morally upright communities, with a progressive economy, smart infrastructures, ecologically sound environment, and efficiently managed institutions through inclusive leadership;

WHEREAS, the City Government of Pasay have existing initiatives on reducing carbon emissions and promoting environmentally friendly transportations as part of the city's comprehensive development plan of building a smart and sustainable city;

WHEREAS, the City Government of Pasay, have existing units of BEMAC E-Tricycles in the city while providing opportunities to the transport groups to increase their income;

WHEREAS, DOST-NCR aims to assist the City Government of Pasay through the deployment of the DOST-funded Electric vehicle fast Charging Technology;

WHEREAS, DOST-NCR has set aside funds from its regional Grants-In-Aid (RGIA) Program and agreed to implement the project titled "Improvement of the Pasay City Transport Group Operations through Integration of Fast Charging System";

WHEREAS, the objective of the project is to support Pasay City's implementation of the Electric Vehicle Industry Development Act (R.A. 11697) through the deployment of CharM (Charging in Minutes) Technology and to validate the data of CHRG Electric Vehicle Technologies, Inc., on the operational parameters of e-vehicles using the CharM fast charging stations specifically to:

1. Provide a fast-charging station that can service at least 25 e-tricycles daily in Pasay

2. Generate an increase in income from Php1,500/day for tricycle drivers using electric tricycles versus gasoline-powered tricycles; and

3. Maximize usage of electric tricycles through decreased charging time, accommodating 40% more passengers and tourists in the city;

WHEREAS, pursuant thereto, Honorable Mayor Imelda Calixto-Rubiano, in an endorsement dated June 2, 2023, has forwarded a copy of the Memorandum of Agreement and requested for the issuance of a Resolution Authorizing the Honorable City Mayor Imelda G. Calixto-Rubiano, to sign the mentioned Memorandum;

WHEREAS, the matter was set for hearing before the Joint Committees of the Sangguniang Panlungsod on June 19, 2023 with the following recommendation in the Joint Committee Report, to wit:

"WHEREFORE, premises considered, the request for the issuance of a legislation authorizing the City Mayor Imelda Calixto-Rubiano to sign the Memorandum of Agreement between the City Government of Pasay and the Department of Science and Technology-National Capital Region (DOST-NCR) for the implementation of the project titled "Improvement of the Pasay City Transport Group Operations through Integration of fast Charging System" is hereby recommended for APPROVAL to the Sangguniang Panlungsod, subject to all applicable laws, rules, and regulations and that a corresponding ordinance be adopted."

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod, in session duly assembled, AUTHORIZING THE HONORABLE CITY MAYOR IMELDA CALIXTO-RUBIANO TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT IN BEHALF OF THE CITY GOVERNMENT OF PASAY WITH THE DEPARTMENT OF SCIENCE AND TECHNOLOGY-NATIONAL CAPITAL REGION FOR THE IMPLEMENTATION OF THE PASAY CITY TRANSPORT GROUP OPERATIONS THROUGH INTEGRATION OF FAST CHARGING SYSTEM, SUBJECT TO COMPLIANCE WITH ALL APPLICABLE LAWS, RULES, AND REGULATIONS.
