WHEREAS, Section 3 of Ordinance No. 5914 Series of 2018 provides for the procedural guidelines on the Review of Barangay Appropriation Ordinances;

WHEREAS, the pertinent provision of ARTICLE II, CHAPTER III OF THE LOCAL GOVERNMENT CODE OF 1991 or R.A. 7160 pertaining to barangay budgets;

WHEREAS, the Supplemental Budget No. 1 of Barangay 89 Zone 09, Pasay City was submitted to the Liga ng mga Barangay for preparation of the necessary sanggunian resolution certifying the review of the Supplemental Budget No. 1 of the barangay and is subsequently filed for inclusion in the agenda of the Sangguniang Panlungsod for final review and approval;

WHEREAS, the appropriation provisions and outlays on the said Barangay Supplemental Budget were likewise previously referred to the City Budget Office, Office of the City Accountant, City Planning Office and to the Committee on Appropriations of the Sangguniang Panlungsod and were found to be accurate, legal and conforms with all accounting and auditing rules and procedures.

WHEREAS, this Sanggunian finds that the aforesaid proposed Supplemental Budget has satisfactorily met the necessary budgetary requirements set forth under the Local Government Code of 1991 and Ordinance No. 5914 Series of 2018.

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, Certifying the Review of the Supplemental Budget No. 1 for Calendar Year 2023 of Barangay 89 Zone 09, Pasay City, is in Compliance and Conformity with Pasay City Ordinance No. 5914 Series of 2018 and Article II, Chapter III of the Local Government Code of 1991 and other Applicable Laws, Rules and regulations as well as Commission on Audit Rules and Regulations on the matter;


