CAVE, AND PROJECT MANAGER, ENGR. FREDERICK T. QUIMPO, FOR THE INSTALLATION OF THIRTY-ONE (31) 32-27.5 METERS STEEL POLES WITH 115KV LINES ALONG WEST SERVICE AND C.P. GARCIA EXTENSION IN BARANGAY 201, PASAY CITY PROVIDED APPLICABLE LAWS, RULES AND REGULATIONS ARE ALL COMPLIED WITH AND SUBJECT TO THE HEREUNDER CONDITIONS**

**SPONSORED BY MEMBERS OF THE SANGGUNIANG PANLUNGSOD**

**Whereas**, there is a request for the issuance of Work/Excavation Permit from MERALCO, represented by its Permits and Right of Way Officer, Dennis S. Cave and Project Manager Engr. Frederick T. Quimpo, for the installation of thirty-one (31) 32-27.5 meters steel poles with 115kv lines along West Service and C.P. Garcia Extension in Barangay 201, Pasay City;

**Whereas**, this application request was conveyed in a letter dated September 16, 2022 signed by Mr. Dennis S. Cave, Officer from Permits & Right of Way Division of Meralco, which letter was endorsed by Engr. Renato A. Sanchez, Officer-In-Charge, Office of the City Engineer/Building Official, to the Honorable City Mayor Imelda Calixto-Rubiano on July 03, 2023 together with the plans and pertinent documents of the Proponent. The same was officially forwarded to the Sangguniang Panlungsod thru the Office of the City Secretariat in an endorsement dated July 6, 2023 for approval and adoption of an appropriate resolution.

**NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED**, by the Sangguniang Panlungsod, **MANIFESTING THE SANGGUNIANG PANLUNGSOD'S NO OBJECTION TO THE REQUEST FOR WORK/EXCAVATION PERMIT OF MERALCO, REPRESENTED BY ITS PERMITS AND RIGHT OF WAY OFFICER, DENNIS S. CAVE, AND PROJECT MANAGER, ENGR. FREDERICK T. QUIMPO, FOR THE INSTALLATION OF THIRTY-ONE (31) 32-27.5 METERS STEEL POLES WITH 115KV LINES ALONG WEST SERVICE AND C.P. GARCIA EXTENSION IN BARANGAY 201, PASAY CITY, PROVIDED THAT THEY WILL COMPLY WITH ALL THE REQUIREMENTS AND ABIDE BY THE LEGAL PROCESSES IN SECURING NECESSARY DOCUMENTS FROM CONCERNED GOVERNMENT AGENCIES; PROVIDED FURTHER, THAT APPLICABLE LAWS, RULES AND REGULATIONS ARE ALL COMPLIED WITH AND SUBJECT TO THE FOLLOWING TERMS AND CONDITIONS, TO WIT:**

- The Proponent or its partner agencies is/are mandated to return the excavation area to its original condition strictly within the period provided for its restoration;
- To ensure compliance with the above, the Proponent is required to post/deposit a bond equivalent to 10% of the restoration cost;


- For the protection of the public, the Proponent is obliged to submit to the City Secretary a Traffic Management Plan in coordination with the Pasay City Traffic and Parking Management Office, including the installation of sufficient warning devices and assigning traffic enforcers at or around the affected area;
- The mentioned contractors are directed to coordinate with each other as to their working hours to mitigate the effect to the traffic in the affected areas;
- The Proponent is mandated to observe standard health protocols in the workplace to ensure the safety of their workers and prevent the spread of COVID-19;
- The clearance is automatically canceled/revoked upon the expiration of the period for restoration. In this regard, the Proponent should secure another clearance for the remaining works;
- The Proponent is required to post proper notices and conduct information dissemination about the project for the benefit of the public; and
- The Proponent must strictly comply with existing ordinances of the City.


